OFFICIAL CONTEST RULES – December 1st 2024

ELIGIBILITY:

This contest is open to all residents of Canada (except where prohibited by law) and the U.S. (excluding Florida) who are 18 years of age or older, except employees and their immediate families of any of the following: Jackpot Time, and its agents, Jackpot Time charities and their volunteers when conducting an event or in the facility in a business capacity, Bingo Country / Jackpot Time suppliers, advertising, promotion and contest management agencies.

1. **How to Enter:** Sign up for the email list at one of our Ipads in our hall at any 4 locations or online on our website. Once all valid details have been completed and submitted; your name will be entered into our new database where you will automatically be entered in our draw to win a trip for 2 to Las Vegas
2. Contest commences on December 1st and prize will be drawn 90 days later which is the contest closing date.
3. Entrants to the contest do not need to be present on the draw date to win or claim their prize. Contest winner will be notified by the email entered during signup.
4. Sign up form must be filled in completely and entrant must consent to accepting emails to qualify.

Odds

The odds of winning a prize in this contest will be based on the number of completed entries that have been submitted. The odds of winning will vary.

Prize:

The prize awarded will be a 4 Days 3 nights Trip to Las Vegas – valued up to \$2000.00 CDN. There will be a cash buyout available if the winner chooses to not take the trip. Value of the cash buyout will be \$1000.00 CDN
